Full membership is the normal category of membership; the great majority of LCSC members are full members.

Family membership may include additional family members in an application. A partner or spouse and any children (under the age of 18) are eligible to participate in all club events - U18's to be agreed on a case by case basis by the Management Committee. Parent supervision will be required for U18's. Please provide details of additional family members on extra copies of the personal details form. (Associate and overseas members may also include family members in their application.)

Country Any person living outside the M25 shall be designated a Country Member and be entitled to Membership at a reduced subscription though will not have use of the Undercrofts and are not full members within the meaning of the rules/bylaws.

Overseas membership is open to persons living and working outside the United Kingdom.

Age group 24-26. Members age 24-26 shall be entitled to Full Membership at a reduced subscription, On proof of date of birth.

Students / 23 & under Members 18 - 23 years of age or in full time education shall be entitled to Full Membership at a reduced subscription, on proof of date of birth or student card.

Associate members are not eligible to take part in club sailing events but can use the club facilities, join shore-based training courses and take part in social events.

Joint membership is open to members of the Sons of the Thames rowing club with which LCSC shares the use of the clubhouse; the reduced subscription rate reflects the sharing of costs between the two clubs.

A reduced concessionary rate is available to long-standing members of the club who have retired but wish to maintain their links with the club. This rate is not available to new members.

PAYMENT OF FEES

Our preferred method of payment is by direct debit and we offer a reduced fee for this. Please complete the attached direct debit mandate and return it together with this application. Otherwise payment, including joining fee where required, by cheque made payable to London Corinthian Sailing Club, by credit/debit card or bank transfer should accompany your application. Thereafter membership subscriptions will be invoiced annually and will be due in the month of joining. e.g.: a member who joins the club in April 2011 will again be invoiced in April 2012.

PROPOSAL AND ELECTION

The constitution of the club requires your application to be proposed and seconded by existing members. If you come to the club, finding these two signatures is normally easy; we do like to meet new members face-to-face. If you really cannot come to the club in person please send in the application by post.

The constitution also requires that members be approved by the Management Committee and elected to the club after an initial period which allows other members to vet the application. However this is a formality and members are free to participate in club events as soon as payment has been received by the club. You will be notified when your election has been formally approved.

LONDON CORINTHIAN TRUST

This is a separate body that owns and runs the club building, Linden House. Membership of the Trust is open to all LCSC members and we prefer club members to join the Trust as well as the sailing club. A separate application form is required.
