### **This Declaration must be signed**

I agree to be bound by the Racing Rules of Sailing and any other instructions issued by WSC for the pursuit racing. In particular, I have read the section in the racing rules covering the risk statement and agree to the statements contained in it.

*Risk Statement: Rule 4 of the RRS states: "The responsibility for a boat's decision to participate in a race or continue to race/participate is hers alone" and that sailing is by its nature an unpredictable sport and therefore inherently involves an element of risk.*

By taking part in a race, each competitor agrees and acknowledges that:

- a. They are aware of the inherent element of risk involved in the sport and accept responsibility for the exposure of themselves, their crew and their boat to such inherent risk whilst taking part in the event;
- b. They are responsible for the safety of themselves, their crew, their boat and their other property whether afloat or ashore;
- c. They accept responsibility for any injury, damage or loss to the extent caused by their own actions or omissions;
- d. Their boat is in good order, equipped to sail in the events and they are fit to participate;
- e. The provision of a race management team, patrol boats if any and other officials and volunteers by the event organiser does not relieve them of their own responsibilities;
- f. Their boat is required to hold adequate insurance and in particular, to hold insurance against third party claims in the sum of at least £3,000,000.

### **Data Privacy**

The information you provide in this form will be used solely for dealing with your entry in WSC Pursuit Racing. WSC has its own data protection policies and your data will be stored and used in accordance with these policies. This form will be destroyed when this year's races are completed, unless the law requires it to be further retained. Please raise any queries concerning this Data Privacy Policy with the Hon Sec. The Policy details how personal data is processed to enable the Club to operate and provide sail racing.
